Feel free to also include any other information that you believe is essential for your prospective employers to know about you.

Please submit your resume and a legal writing sample no longer than 5 pages with this application. A suitable writing sample could be an excerpt from a legal writing class assignment, a portion of a law review or journal note, or an essay submitted in connection with your legal course work.
